

2024 Pacific Fellowship Grant - Call for Proposals

Background:

The mission of the Pūtahi Manawa | Healthy Hearts for Aotearoa New Zealand (HHANZ) Centre of Research Excellence (CoRE) is to improve equity in heart health for Māori, for Pacific Peoples and for women through research excellence and precision medicine. Pūtahi Manawa brings together research scientists, clinicians, educationalists and communities by comprehensively and collaboratively addressing issues around equity in heart health outcomes to support and complement the public health approach. We work in partnership with communities and researchers to create a vibrant world-class environment and network for heart research in Aotearoa New Zealand that is underpinned by evidenced based, multi-disciplinary collaborative research that delivers clinical benefits and heart health equity to patients.

About the Fellowship Grant:

The purpose of these Fellowship Grants is to provide direct support for Pacific researchers undertaking research in Aotearoa New Zealand on heart health (minimum of 0.6FTE p.a.).

Grant duration and funding:

The fellowships aim to support up to a three-year period and include salary for the fellow (up to 1.0 FTE per year) plus research working expenses of up to \$100,000 in total over a three-year period.

Eligibility:

- To be considered for this fellowship, you must be of Indigenous Pacific descent.
- You do not have to be a New Zealand Citizen or Resident to be eligible, but you must have a right to work/hold a current visa to work in New Zealand. The fellow must be based in New Zealand but may undertake some of the research overseas.
- You must have completed a postgraduate degree at doctorate level **OR** have at least three years' experience at a level equivalent to research undertaken for a doctoral degree.
- All proposals should be aligned with our CoRE principles as outlined at the end of this document.
- Applicants must adhere to the guidelines and space limitations as detailed in the call for proposals and the application form, otherwise the application will be disqualified.

Doctoral Degree:

For those applicants who do not have a doctoral degree, Pūtahi Manawa supports the option to undertake study for a doctoral degree as part of the fellowship. If the fellow is admitted onto a doctoral programme at a NZ university, the research work undertaken for the fellowship, which will need to be completed under supervision, would comprise the research project for the degree. The salary (see "Salary costs" in Budget section below) and working expenses would remain the same as if the fellow was not studying for a doctoral degree. The fellow would not be eligible for any doctoral scholarships or stipends in addition to the salary. - Salary costs: The fellowship will pay salary costs according to the experience and seniority of the Fellow at an equivalent level of up to seven years research experience on the academic scale in the first year of the fellowship, increasing thereafter, plus the organisation's standard overhead rate.
- Research expenses: The fellowship will pay up to a maximum of \$100,000 NZD project costs/consumables over three years. Please provide an itemised breakdown of research costs to fully justify the budgeted expenditure.

Scoring and Weightings:

- Section A: Fellow, equity statement, career plans/future directions, and mentoring team (40%).
- Section B: Proposed research to improve heart health and heart health equity (30%).
- Section C: Alignment to CoRE principles (30%).

Conditions:

- Where the applicant is eligible for a fellowship via the completion of a doctoral level degree, the applicant must have submitted their thesis before the application closing date. The examination committee must have recommended the PhD be awarded before a fellowship can commence.
- The start date and end date of the fellowship must be stated
- Presentations or publications or media (eg, press releases), or patents resulting from the fellowship will acknowledge Pūtahi Manawa's support and be submitted as part of regular reporting.
- The applicants' host institution will administer the fellowship. If there are changes in details of the fellowship or research project, a variation request will need to be submitted to the Pūtahi Manawa | HHANZ CORE administration team.
- Yearly reporting will be required. If it is deemed that inadequate progress has been made, a review may be triggered. A final report will be required within 3 months of the fellowship end date.
- It is expected a contribution will be made to outreach and education activities, which will also be included in the reporting.
- The fellowship is generally a minimum of 0.6FTE p.a. but a lower FTE may be allowed with prior approval before the application is submitted.

Conditions:

Should an applicant be selected for interview, they are permitted to bring a support person to the interview, provided there is no conflict of interest.

Please note the support person CAN

- Provide emotional support
- Observe the interview
- Respect and maintain confidentially at all times
